Key takeaways from the 1st edition

- 18 eligible cities applied from across the EU
- 7 cities shortlisted, 1 Award Winner, 4 Special Mentions
- Network of EU Cities for Fair and Ethical Trade (since 2018)
- Development Cooperation Project connecting Ghent, Belgium and Sahnewal, India facilitated by ITC (since summer 2019)
- Sustainable Trade Champions report (January 2020)

Commonalities between **front-runner cities** at the level of individual activities:

- ✓ Target **public procurement** to make it more sustainable;
- ✓ Produce sustainable shopping, catering and restaurant guides;
- ✓ Organize **guided city tours and/or labels** to inform citizens and visitors about opportunities for responsible consumption choices;
- Organize dedicated events to enhance awareness and understanding amongst citizens;
- ✓ Focus on educational initiatives to sensitize and inform the youngest of their citizens; and
- Develop online information and tools.

Sustainable Trade Champions 2019 report

- In 2017: no precise definition of 'fair and ethical **trade**' under the Award
- 2017 'Living Book'
- Intention: let the cities construe the meaning in their submissions, collect as many stories and cases as possible
- Applications revealed:
 - an <u>impressive number</u> of fair and ethical trade initiatives led by EU cities and their citizens
 - how EU cities are already <u>driving positive change & changing mind-sets</u>













ITC-Ghent development project with Sahnewal, India

A unique city-to-city cooperation project, with the UN (ITC), the European Commission, and a local NGO

Textile value chains: connecting with the cities' DNA

OUTPUTS

MAPPING: assessment of the municipality needs and capacity gaps on sustainable production — **a report and work-plan** for decision-making

INTERACTIVE WORKSHOPS: exchange with Ghent on creation of enabling environment for a local ecosystem conducive to responsible/sustainable production; supporting community participation; scaling-up

WHO?

Cities in EU member states with >20,000 inhabitants

 Any city stakeholder can launch the application, subject to an official submission & Mayor's approval

WHAT?

Coherent approach to sustainable, fair and ethical trade through:

- Vision, strategy & objectives
- 2. Relevant policies
- 3. Impactful activities & initiatives











Applying for the Award

WHY?

- Prestigious recognition
- Increased visibility
- Inspiration for your local activities
- Development cooperation project outside of EU
- Promotion of pioneers in the Sustainable Trade Champions report
- Join shortlisted cities in the Network to learn & collaborate

Applying for the Award

APPLICATION PROCESS

- Easy application process via online application portal
- Application in English is encouraged, but possible in any of EU 24 working languages
- Evidence to support the claims made in their narratives (3 pieces/question)
- Concise: word limit + application length limit (4,050 words)
- Mayoral declaration mandatory
- Applicant webinars February-May 2020
- Network to learn & collaborate













Applying for the Award

APPLICATION FORM

- City Summary Pitch
- City Context Criteria
- 6 main questions:
 - 1) Vision, objectives, motivation
 - 2) Policies, systems & actions
 - 3) Creating enabling environment and raising awareness
 - 4) Initiatives by city's stakeholders
 - 5) Measurement & evaluation systems
 - 6) Development project ideas













Applying for the Award

EVALUATION CRITERIA

- Criteria cover overarching substantive aspects of the application:
 - (i) Overall direction and strategy
 - (ii) Depth and innovative aspects of initiatives
 - (iii) Stakeholder engagement and participation
 - (iv) Measurement, evaluation and impact
 - (v) Presentation & communication of the content in the application
